SUBJECT: Current Salary Levels of State and County Elected Officials

This memorandum responds to your request for current salary levels of state and county elected officials. Constitutional and statutory provisions prescribe these salary levels. Table 1 provides current salary levels for Colorado's Governor, Lieutenant Governor, Attorney General, Secretary of State, State Treasurer, members of the General Assembly, members of the University of Colorado Board of Regents, and Colorado district attorneys, as set forth in state law.

Salaries of state elected officials and district attorneys. The Colorado Constitution prohibits the General Assembly from altering the salaries of current legislative members. The General Assembly may determine the salary levels of future members. This constitutional provision also requires that members of the General Assembly receive the same travel mileage reimbursement rate that is available to other state employees. The Colorado constitution also prohibits the General Assembly from increasing or diminishing the salaries of the Governor, Lieutenant Governor, Attorney General, Secretary of State, State Treasurer during their official terms.²

Salaries of Colorado county officials. Salaries paid to Colorado county officers vary by office and the statutory category of a county. Table 2 provides current salary levels of county officers for terms that began after January 1, 2007. County officers serving terms that commenced prior to January 1, 2007, are compensated at lower salary levels.

The Colorado Constitution requires the General Assembly to fix the salaries of county officers.³ In fixing county officer salaries, the General Assembly must consider the following:

• county population;

- the number of persons residing in unincorporated areas of the county;
- the county assessed valuation;
- county tax resources;
- motor vehicle registrations, building permits, and military installations in the county; and
- other factors reflecting variation in workload and responsibilities and of the counties.

The salaries of county officers may only be increased or decreased when the salaries of all county officers within a particular county are altered or when the compensation provided for a particular county office statewide is altered. The compensation of county officers may not be altered during the term of office for which a county officer has been elected or appointed. Colorado counties (not including the City and County of Denver and the City and County of Broomfield) are separated into six categories for purposes of fixing the salaries of county officials. As noted above, the General Assembly considers county population in determining the appropriate salary level categorization for county officials.

Salaries of county government elected officials are periodically examined by a 13-member County Elected Officials' Salary Commission.⁴ The commission is charged to study and make recommendations to the General Assembly every four years relating to:

- salaries paid to county elected officials;
- the responsibilities of each county elected official and the scope of authority of the entity in which the official serves;
- the relative level of difficulty in performing the duties of each county elected official;
- the amount of time directly or indirectly related to the performance of the duties, functions, and services of each county elected official; and
- current levels of salaries for comparable public and private employment.

The commission most recently issued a report for 2010.
